 - Two (2) passport-sized photographs
2. **Fees Payment**
 - Original bank documents must be provided to LSBF as proof of payment.
 - The information in the Fee Schedule is accurate at the time of printing; however, LSBF reserves the right to make necessary changes without prior notice.
 - All fees must be paid before the commencement of the semester (for Malaysian students) or the academic year (for international students) in accordance with the approved payment structure. Failure to comply may result in termination of enrolment by LSBF.
 - International students are required to pay the first year's fees upfront.
 - Late payment charges of RM50 per week will be imposed on students who do not settle their tuition fees by the stipulated deadline set by LSBF
 - If a student withdraws from their course within the semester/year, the student remains liable for the full semester/year fees.
 - Students are responsible for regularly checking their outstanding fee status at the Finance Department and ensuring timely payment.
 - PTPTN loan amounts may fluctuate and are subject to PTPTN approval.
 - Students are required to consult the Student Handbook for additional terms and conditions and must comply with these terms.
3. **Refund Policy**
 - There are no refunds or transfers of registration, processing, and accommodation fees under any circumstances.
